This template can be used for multiple purposes:

• It enables schools to effectively plan their use of the Primary PE and sport premium

• It helps schools to meet the requirements (as set out in guidance) to publish information on their Primary PE and sport premium

• It will be an effective document to support Ofsted inspections enabling schools to evidence progress in Physical Education (PE) and evidence swimming attainment, which forms part of the PE National Curriculum. We would recommend schools consider

the Intent, Implementation and Impact of any spend, as examined within the Education Inspection Framework.

It is important that your grant is used effectively and based on school need.

Schools must use the funding to make additional and sustainable improvements to the quality of the PE, School Sport and Physical Activity (PESSPA)

they offer. This means that you should use the Primary PE and sport premium to:

- Build capacity and capability within the school to ensure that improvements made now will benefit pupils joining the school in future years
- Develop or add to the PESSPA activities that your school already offers.

The Primary PE and sport premium should not be used to fund capital spend projects; the school's core budget should fund these. Further detail on capital expenditure can be found in the updated <u>Primary PE and sport premium guidance</u>.



The Primary PE and sport premium guidance, outlines 5 key priorities that funding should be used towards. It is not necessary that spending has to meet all the key priorities, you should select the priorities that you aim to use any funding towards.

Although completing this template is not a requirement for schools, schools are required to publish details of how they spend this funding. Schools must also outline what the impact this funding has had on pupils' PE and sport participation and attainment and how any spending will be sustainable in the future. All funding must be spent by 31st July 2024.

The Department for Education has worked closely with the Association for Physical Education (afPE) and the Youth Sport Trust (YST) to develop this template and encourages schools to use it. This template is an effective way of meeting the reporting requirements of the Primary PE and sport premium.

CPD opportunities are still going ahead Autumn 25 through PSSP which will target new staff/ECTS and staff who have not received CPD training recently. Staff who have had CPD are able to plan and teach lessons more confidently and can share some of their learning with other members of staff.

An audit was completed of current resources and resources were monitored to ensure that they were suitable for use and there was enough for everyone to use during their lessons.

- Staff have been able to take what they have learnt from the CPD opportunities and are feeling more confident in teaching certain aspects of PE.
- New scheme of work has been looked into and is set to begin Autumn 25. This new scheme has an integrated monitoring and assessment system which is easily accessible for teachers and will support teachers with assessing the children's attainment and progress.

- New resources ordered, and, delivered. Summer 2025. These new resources will benefit the children in trying out new sports.
- New curriculum is due to be implemented in the Autumn of 25 which will offer a range of different sports/activities.
- We are introducing a specific area in the playgrounds for children to be able to access structured sports and physical activities alongside the space for free choice physical activity.

 Resource and Curriculum Improvement:

New resources to be purchased to support the implementation of our new curriculum.

• Collaborative Planning:

A new curriculum has been implemented to ensure that teachers have a clearer understanding of lesson progression and assessment. Having a clear assessment system that is easily monitored in extremely important.

Promoting Physical Literacy:
Staff are to understand the importance of physical literacy.
Fundamental movement skills is to be specifically taught in the earlier year groups to ensure those foundational skills are embedded. We are also looking at a skills based curriculum rather than just a sports based curriculum to ensure that the children have transitional skills and we are developing the child holistically.

curriculum, and will, develop transferrable skills which they could call upon in other areas of the PE curriculum. Each staff member chosen has been chosen due to being an ECT, lacking confidence in teaching PE or not having regular CPD opportunities. Across the year, there is a chance for up to 12 teachers to engage in CPD with a specialist teacher.

To implement a new curriculum with a specific focus on developing a clear assessment system and ensuring that children are using Sports Specific Vocabulary,

All pupils and staff

Staff report that they have the correct and appropriate amount of resources to teach their curriculum with three classes per year group. Children are inspired by the new sports that they are experiencing.

Key Indicator 4 - Broader experience of a range of sports and activities offered to all pupils

#### • Curricular PE:

A new scheme is being rolled out September 25 which offers a broad and balanced range of sports and activities such as gymnastics, dance, athletics, swimming, and various types of games. We have ensured that children have the opportunity to come back to certain sports in different year groups to enable them to build on their prior knowledge.

#### Variety of Sports:

This year, we will be introducing a wider range of sports and physical activities within lessons.

#### Modified Sports:

In every year group, we are including a modified versions of recognized sports, like flag football, tri-golf to make them more accessible to all pupils. These games are also games which are unfamiliar to the children and therefore all children will start on an even playing field.

PE lead to support staff with the change to new scheme of work.

PE lead to ensure that there is a range of different activities offered across the year groups so that the children are exposed to a breadth and variety of sports. Each year group to have a modified sport included and resources are to be purchased.

Use PE passport to track and monitor children's progress to create a clear assessment system which can be completed during lessons on the iPad. PE lead to monitor during MER cycle.

Two PE boards to be set up in the halls which will promote the vocabulary and language we want the children to use.
